When using near edible crops, apply a perimeter application. **4:** Allow 20 minutes for the product to dry before watering of any kind. **5:** Repeat application as needed, usually every 30 days. **NOTE:** Due to possible allergic reaction to one or more of the ingredients used to make this product, do not apply to plants that are grown for human or animal consumption. When spraying, ensure that the product does not contact food plants. It may, however, be used on dormant fruit and nut trees. This product works by smell and taste.
