Greens, Tees and Fine Turf:

Apply 2.0 - 4.0 oz. of **Green-T® Micro Pack** with 1.5 - 2 gallons of water per 1,000 sq.ft. (0.7- 1.4 gallons of **Green-T® Micro Pack** with 66 - 88 gallons of water per Acre). Apply every 10 to 14 days throughout the growing season.

Fairways, Roughs, Sports Turf and Lawns:

Apply 1.0 - 2.0 gallons of **Green-T® Micro Pack** with 44 - 88 gallons of water per acre. (3.0 - 6.0 Oz of **Green-T® Micro Pack** with 1 - 2 gallons per 1,000 sq.ft.) Apply once or twice per month throughout the growing season.

Deep Root Injection of Trees & Ornamentals:

Maintenance Rate: 32 oz. per 100 gal. at 5 gal. DBH (Diameter at Breast Height) per inch.
Corrective Rate: 64 oz. per 100 gal. at 5 gal. DBH per inch.
