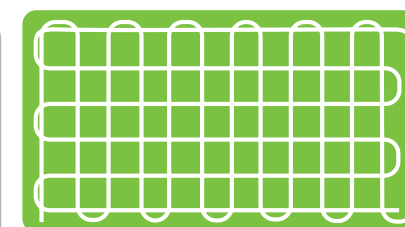
READ ENTIRE LABEL AND USE ACCORDINGLY.

WHERE TO USE: Lawns, Around Home Foundations (Perimeter Treatment), Landscapes (Ornamental and Flower Gardens).

HOW TO APPLY: (Use higher application rates for severe infestations – reapply as needed)

ON LAWNS – Using a rotary or drop spreader designed for application of granular materials, uniformly apply 2 to 5 lbs. over 1000 sq. ft. (Note: 1000 sq. ft. = 20 ft. x 50 ft.) Reapply every two to four weeks or as needed.

CRISS-CROSS APPLICATION

* Settings are approximate. The condition of your spreader, the speed at which you walk and uneven terrain may affect the rate of application. Calibrate your spreader according to the manufacturer's directions. Be sure the spreader works properly and spreads granules evenly.
** A criss-cross application up and down the intended area is required to achieve pounds per sq. ft. indicated (see diagram).

LANDSCAPES (Ornamentals & Flowers) – Using a handheld spreader or by hand broadcasting (it is recommended to wear a protective glove if applied by hand and wash hands with soap and water afterwards) apply 1 to 2 lbs. evenly over each 500 sq. ft. area (Note: 500 sq. ft. = 5 ft. x 100 ft.). Reapply every four to six weeks or as needed.

HOME FOUNDATIONS – Using a handheld spreader or by hand broadcasting (it is recommended to wear a protective glove if applied by hand and wash hands with soap and water afterwards), evenly apply a 2 ft. wide band next to the home foundation. Use 1 to 2 lbs for each 500 linear ft. (Note: 500 linear ft. = 2 ft. x 250 ft.). Apply under / around all landscaping adjacent to home, especially mulch. Reapply every two to four weeks or as needed.

Note: The granules do not need to be watered after application, but water (rain, sprinklers, etc.) should not adversely affect performance.

PRECAUTIONARY STATEMENTS: Caution - We recommend good safety practices when using any pesticide, such as avoiding contact with eyes and skin and keeping out of the reach of children. If product gets in eyes, flush with water. If on skin, wash with soap and water. If irritation persists, contact a physician.

STORAGE AND DISPOSAL: Store in a cool, dry area and avoid excess heat. For bags after partial use, reseal opened bag by folding top down and securing. Discard empty bags in trash.
